

AN ORDINANCE AMENDING ORDINANCE NO. 15, SERIES OF 2022, ENTITLED: "ORDINANCE CREATING THE NORTHERN SAMAR PUBLIC EMPLOYMENT SERVICE OFFICE (NSPESO), ELEVATING THE SAME AS A SEPARATE DEPARTMENT OF THE PROVINCIAL GOVERNMENT OF NORTHERN SAMAR RE-TITLING, AND SUBSEQUENTLY ABOLISHING/DISSOLVING ADMINISTRATIVE AIDE VI (STENOGRAPHER II), SG-6 (ITEM NO. PPDO 6-8); ATTORNEY III, SG-18 (ITEM NO. PLO 99); COMMUNITY AFFAIRS ASSISTANT I, SG-5 (ITEM NO. PCCAO 184-6); & ADMINISTRATIVE AIDE I (UTILITY WORKER I), SG-1 (ITEM NO. NSPH 11-25) TO PROVINCIAL GOVERNMENT ASSISTANT DEPARTMENT HEAD, SG-24 (ITEM NO. NSPESO 54-16) TO COVER THE SALARIES, OTHER COMPENSATION, AND BENEFITS ATTACHED TO THE POSITIONS UNDER THE SAID NEW DEPARTMENT, RETAINING THE EXISTING PLANTILLA POSITIONS AS WELL AS PERSONNEL AND THEIR CORRESPONDING PLANTILLA ITEMS IN THE PROVINCIAL GOVERNOR'S OFFICE (PGO), PROVINCIAL COOPERATIVE AND COMMUNITY AFFAIRS OFFICE (PCCAO), AND PROVINCIAL GENERAL SERVICES OFFICE (PGSO) TO FORM PART OF THE ORGANIZATIONAL STRUCTURE OF THE NORTHERN SAMAR PUBLIC EMPLOYMENT SERVICE OFFICE (NSPESO)", PARTICULARLY SECTION 3 THEREOF

Section 1. Section 3 of Ordinance No. 15, Series of 2022, entitled: "An Ordinance creating the Northern Samar Public Employment Service Office (NSPESO), elevating the same as a separate department of the Provincial Government of Northern Samar retitling, and subsequently abolishing/dissolving Administrative Aide VI (Stenographer II), SG-6 (Item No. PPDO 6-8); Attorney III, SG-18 (Item No. PLO 99); Community Affairs Assistant I, SG-5 (Item No. PCCAO 184-6); and Administrative Aide I (Utility Worker I), SG-1 (Item No. NSPH 11-25) to Provincial Government Assistant Department Head, SG-24 (Item No. NSPESO 54-16) to cover the Salaries, Other Compensation, and Benefits attached to the positions under the said new Department, retaining the existing plantilla positions
